Guidance Notes

- 1. Abstral should only be considered for patients taking the equivalent of 60mg oral morphine for a week or longer
- 2. This chart should only be used for the titration of Abstral. During Titration, Abstral should **ALSO** be prescribed on the prn section of the drug chart and state Please see Attached Abstral Titration Chart as shown in the example
- 3. When a therapeutic dose of Abstral has been achieved, the titration chart should be discontinued and the maintenance dose prescribed on the prn section of the drug chart as shown in the example
- 4. Different formulations of fentanyl containing products are not interchangeable. Patients switching fentanyl brands require a new dose titration.
- 5. The total dose for a single episode of breakthrough pain during the titration phase includes the first tablet(s) taken plus the supplemental tablet(s) if required
- 6. No more than four (4) tablets should be used at any one time NB Price per tablet is the same regardless of strength
- 7. Patients should wait at least 2hours before treating another episode of BTP (breakthrough pain) with Abstral consider prescribing an alteratiive analgesic alongside that can be given hourly if required
- 8. The usual recommendation is for Abstral to be administered for a maximum of 4 episodes of BTP in 24 hours, but there may be occasions when it may be appropriate to exceed that recommendation.

During the Titration Phase ensure administered doses are recorded on this form and not the main drug chart
